From the Mayor's Desk

Well, fall is here, and what a busy year. We have accomplished much over the year and more is still to come. With the passing of the new Transient Rental and Building Inspection legislation, I believe we will deter the process of Kelleys Island becoming a more commercial as opposed to a quiet residential island. We must keep moving forward to keep our island the way we all remember it. The next item on the agenda is to settle the current airport issue. This issue has been going on since the 50's and we are finally moving along to get some resolve to it. The airport is currently operating and has been for years in violation of FAA safety rules. There has been some extension in time given by putting height restriction signs, flashing stop signs, shortening the actual runway by 200'. I believe we must act before the FAA says we will have to close our airport due to Safety Violations. That being said, the one option on the table is to close Monaghan Road at the airport. Other options are using a gated system which is not allowed by the FAA, building the runway into the lake or building a bridge over Monaghan Road. The Village, along with our consulting firm, has come up with 9 alternatives with the closing of the road being one of them. I believe that this action compatible of the second that this option cannot happen. It is a Safety Issue. Closing the road would affect the northeast quadrant of our island, including everything north of the Four H Camp, Long Point, Maryanne, and Lincoln areas. It would also greatly affect those on the East/Southeast side of the island. Safety would be compromised for those people. Imagine an emergency run on Harbor where the ambulance would have to go to the airport on Woodford, Division, Ward/Hamilton, and finally to the airport because of the closure. All involved must come up with a compromise to solve this problem and to keep our airport up and running. This is a huge safety issue involving human lives.







Council Notes

Another full house as attendees waited to see if the Transient Rental Property (TRP) ordinance passed. It did. The language in the ordinance was updated with each reading and has changed significantly since its first presentation to Council. Dead links to the Ohio Revised Code or to sections in the ordinance were corrected and an outside contractor will be doing the safety inspections which, along with the septic system inspections, will be good for 3-years, even if the property changes hands (and the property had a valid permit when sold). The effective date is October 1, 2024 and the village is, apparently, working on hiring a clerk and setting up the registration website. No public meetings are (as yet) scheduled to explain the requirements of the new code section. In reviewing the ordinance, Registration will open on October 1. The property owner must then apply for a permit. Within 45 days of applying for a permit, the owner must submit a Safety Inspection completed by an Ohio Certified Home Inspector and proof of a 3-year inspection of the septic tank. The permit will be approved when all deficiencies are resolved and the Village reviews and approves the permit. Absolutely no rental occupancy will be allowed until the TRP certificate is issued. The full text of the ordinance can be found under the heading Ordinances, on the Village website (KelleysIsland. us).

The Village also adopted Village Building/Mechanical/Plumbing Codes and Building Standards which incorporates various sections of the Ohio Building Code included in the Ohio Revised and Ohio Administrative Codes. A third ordinance, a new chapter entitled Residential Code for 1-2-3 family dwellings, adopting and including several Ohio Revised Code sections, had its second reading. Village ordinances are posted in public places and on the Village website within days of being passed.

A contract was awarded to K.E. McCartney & Assoc. (to provide plans, studies and dates) for the existing [sewage] systems, including pump stations, and to investigate the feasibility of sanitary areas and connections. Work includes meeting with property owners to determine locations and condition of their facilities, and develop project alternatives for sanitary service and wastewater treatment. The initial contract is for \$300,000.

The KI EMS reported 26 runs and 31 clinic calls. The Fire Dept. had 2 runs. The Police Dept. received 15 reports, fielded 380 phone calls, made 10 arrests including 2 traffic (motor vehicle accidents and an OVI hit-skip) and issued 4 tickets for Open Container/D.C. The Park Board received a \$109,000 Erie County Community grant for the park which should finish up the landscaping and other items. In 2017/18, the airport received \$82,000 for improvements; however, the FAA recently determined that that was awarded in error. The Village did a comprehensive justification and the amount the FAA agreed to take back was just \$16,000.

The Neighborhood Exchange

It is often said, "your life does not get better by chance, it gets better by change." Seasons change. People come into and out of our lives. And one constant we endlessly endure, is change. Life on Kelleys Island is no different. Generally speaking, the island life is both beautiful and vibrant. And as we near the end of another summer season, the winds of change are blowing.

How do we responsibly implement and live with new regulations on Kelleys Island?

Likely the best way is clear communication. Especially from KI leadership. And there is a saying,

it is not possible to over communicate... Especially with endeavors involving government and real estate. The island has been void of regulation in some critical areas for a rather long time. Recognizing this, and to their credit, Village Council... along with community members, are publicly and privately discussing the best paths forward on a litany of topics. One such topic involves the Vacation Rental (aka - Short-term rental) ordinance that was passed on Saturday August 10th, 2024.

KI has chosen to adopt the term Transient Rental Property ... The topic has gone largely unnoticed despite conversations dating to the latter half of 2023... With as much experience as our family has with vacation rentals, we too did not recognize the term - Transient Rental Property.

Unique verbiage aside...Responsible regulation of short-term rentals is both encouraged and necessary. Regulating short-term rentals across the country is the same...necessary. You will be glad to know that many property owners on KI have personal and public service experience with this topic in other parts of the country. And even still...the ordinances, as written, represent a good start while leaving many to wonder... What is next?

Why not also consider getting input from those experienced in this topic?

In fact, earlier today, I attended a KILA meeting with approximately 30 property owners of the KI community. Opinions abound about how to implement responsible regulations. One key takeaway from the meeting: In a room full of people, a simple show of hands question and answer session uncovered both attendees and the KILA Board unanimously agreeing on adopting and supporting responsible regulation.

I was not surprised. Again, we seek responsible regulation. The open door meeting contrasted those held by our elected officials (Village Council). The KILA meeting was longer than a Council meeting. The welcoming, question and answer format produced some key initiatives that we will, yet again, present to Village Council. Along the way, and despite several invitations and public comments requesting that we submit ideas and issues, the Village Council has not accepted the efforts to participate in Open Forums and/or Town Hall style information meetings.

And then, in sidewalk conversations with a few people, Mayor Ehrbar himself has asked that issues and ideas be submitted prior to the passing of legislation. We submitted them both individually and as a group. The Mayor and Village Council ignored them. No response to several group emails. No offer to be heard.

Why?

Unfortunately, Village Council responds infrequently to their constituents on this topic. The most recent response by email for our Public Meeting request was met with a rather basic response, "Not at this time," by Mayor Ehrbar.

What is the Village Council trying to accomplish by ignoring public interest on such a misunderstood and polarizing topic? And it is not for lack of trying... We all see that the Village Council is trying.

The disappointing reality is, Village Council chooses to not work collaboratively. And we can see the struggles. Mind you, we also see the successes. We see all of this and are willing and able to help.

Do Council members and others on the island truly seek to understand? Simply reading the hastily passed 11.2 ordinances from August 10th tells a hurried story. The ordinances themselves are fraught with typographical errors and missing verbiage. How did we arrive here?

Why not choose and implement responsible regulation with collaborative input? What is the hurry? How do we comply with an effective date of October 1st 2024?

Further, the August 2024 version From the Mayor's Desk of the paper Life On Kelleys, the Mayor tells islanders how, "The rental business has caused the home values to double in value which leads to higher taxes. There is nothing protecting the longtime retired homeowner from these taxes and will eventually be forced from their homes that they worked all their lives for."

Data integrity is very key to this topic. Property values have... Doubled from what? And from what point in time (origin)? The Mayor's comments are simply unfounded conjecture at best. They are hyperbole at worst. What was the end goal of these comments?

Is he aware that Ohio has a Homestead Exemption that may also assist retirees age 65 and older with prospective property tax payments?

For context, a snippet from a State of Ohio Certified Real Estate Appraiser:

Regarding real estate taxes and valuations leading to real estate tax appraisals. Assessment value is based on a date in time. Typically, the 1st of January. Example, a property that is assessed in 2023 is valued as of January 1, 2023. Any estimate of market value is extracted from the market as of the date of appraisal and prior. County tax assessments are performed on a Mass Appraisal Basis. Mass appraisal as defined by IAAO is "the systematic appraisal of a group of properties as. of a given date (January 1 with the exception of inventory, which may be appraised at its. market value as of September 1) using standardized procedures and statistical testing (Appraisal Institute). Taxes are reassessed in every county in the State of Ohio every 6 years. The county auditor chooses a company or group of companies to perform a mass appraisal to determine the current market value of each property. Highest and Best use to determine real estate values are Comparable Sales. Sales of similar location, utility, condition and use. Sales must be Arms-Length Transactions. Each parcel of real estate is valued based on real estate improvements and land only! Income Approaches are not used in estimating values of real estate in tax assessments. Cost Approaches are also not used in estimating the value of real estate.

Curator, Carmen Smith, has begun an immense project of cleaning and organizing the collection. Last winter, work was completed to protect the archived collections with a climatically controlled storage room for archived artifacts. The Museum Gift Shop and Museum is managed by Justiina Loveless. She invites you to become part of the Museum Volunteer group who works at the Museum during seasonal hours. Reduced Seasonal hours will continue until (tentatively) mid-October. A new volunteer receives excellent guidance from a seasoned volunteer. Greeting and welcoming visitors, along with checking out gift shop items and accepting money for museum admittance is part of your experience. Volunteers receive perks such as 30% off in the Museum gift shop and an appreciation party at the end of the season (this year was held at The Crooked Tree Winery!). While volunteering at the museum you can explore the exhibits and become more familiar with the rich Island History. Resource books are available for you to peruse and to follow an interest in the history of the island that you may have. Don't worry if you have limited knowledge! The books and exhibits can easily be referred to, or you can reach out to another person or inform the questioning visitor that you could get back to them! Typical fun hours are from 12-2, or 2-4, or 12-4. To be open daily is the goal, but without enough volunteers, the museum has had to shorten its operating hours this past 2024 season. Help the Museum OPEN 7 days a week in 2025! Volunteer and experience the benefits of learning the history and having fun with this valued group in our community. The Parsonage House Resale Shop and Sis's Cottage are part of the Museum Campus next to the German Reformed Church. The Parsonage House Resale Shop has become a valued resource to the Kelleys Island Community, providing necessary (and sometimes fanciful) items for the Islanders and visitors, without having to leave the island! Items no longer valued or needed can be donated (following donation guidelines), reducing the need for items to be hauled off the island, AND becoming a needed item or resource for the next person! Volunteers are needed in this exciting venture! Doing light cleaning tasks or helping to stage items, as well as

It is well understood that the root cause of home price increases throughout our country is a lack of supply and an increase in demand for housing. Further, we own housing on an island with even more constraints - less land!

Rhetorically, why have property values increased nationwide in communities with few, if any, short-term rentals? To the point: Unclear messaging or misunderstood roles and responsibilities can lead to conflict and reduced effectiveness. On the other hand, a clear understanding of roles and responsibilities can lead to more collaboration and increase the effectiveness of all participants. It was not but last year, the summer of 2023, that Mayor Ehrbar asked to rent our home for his own family and friend gathering. We are his next door neighbor. We accommodated his request then. And while we did not host his family and friends last year, schedule permitting, we will accommodate his family were he to request using our home again.

As a whole, let us welcome change with open arms. Embrace change transparently. Seek to understand. Work together... Village Council, I speak for many: Allow our collective voices to be heard publicly and with dialogue.

Coining a phrase... Rising tides floats all boats.

Kelleys Island is magnificent. We are primarily a vacation destination visited by many thousands of people each year. It is well known that vacationers are our economic livelihood. And with all of this, I have yet to meet any person, in any capacity, that does not share the desire to ensure the continued vibrancy, character, and charm of the Village of Kelleys Island as a community.

As summer winds down, the weather continues to be beautiful to head outside and enjoy the natural beauty of Kelleys Island. Throughout the fall, the Kelleys Island Audubon Club (KIAC) offers many opportunities for residents and visitors to venture outdoors and explore.

September 1 (1:00 – 2:00 PM): Glacial Glimpses. Join KIAC President Pat Hayes and KI State Park Manager Chris Ashely at the Glacial Grooves for a guided, informative tour of the newly renovated site. There is no need to register for this free event.

September 19 (6 PM): KIAC Monthly Meeting. Join us at the KI School for a pot-luck dinner at 6PM followed by a presentation at 7PM by Katelyn Shelton, a student at Otterbein University majoring in Zoo and Conservation Science, with an emphasis on Avian Studies. Ms. Shelton will be presenting a talk on Piping Plovers, a small shore bird that is considered "endangered" in the Great Lakes region due to destruction of its nesting habitats.

September 22 (6 AM-2PM): Feathers and Foliage. Join Tom and Paula Bartlett at the Banding Station in the Jones Preserve on Long Point as they conduct their avian research study of the fall migration of songbirds. This support facilitated transportation to and from Kelleys Island from the mainland, allowing more participants to join our programs and events. These programs brought together a variety of educational organizations, including universities, local parks, educational nonprofits, conservation leaders, and other island advocates, who all help make these programs possible for the island community and visitors.

The Erie Community Foundation supported a one-day Project WET Workshop for Éducators by contributing over \$3,000 to the workshop. Project Wet is an international organization dedicated to solving critical environmental challenges by teaching the world about water. This workshop gave all participants an integrated set of tools and lessons that emphasized inquirybased, hands-on, and cooperative learning strategies, demonstrating classroom effectiveness for PreK to University students. We collaborated with the Ohio Geological Survey, the Ohio Division of Natural Resources, The Ohio EPA, and Put-in-Bay High School Science Teacher Missi Kowalski. Missi is on the Science Education Council of Ohio as the Secretary and Lake Erie Islands Nature and Wildlife Center board member. These collaborators contributed their time and resources to teach lessons related to Lake Erie for the participants to use in their own classrooms and educational settings. This summer, we reached out to over 3,500 participants who came to our programs and events, including Science Saturdays, School Tours, Nature Story Hours, Pollinators & Pancakes, Nature Camp, many school groups, and more. Thank you to everyone who attended these fun programs and supported the Field

2024 Fall Monarch Article

Jackie Taylor, Director **Kelleys Island Schools Field Station**

Each fall, around mid-September, many monarch butterflies are observed crossing over the Great Lakes, heading south to Mexico to their overwintering habitats. The Eastern Monarch Butterfly's range extends across three countries: Southern Canada, The United States, and Mexico. The butterflies travel up to 2,500 miles, and it takes them about two months to complete their annual migration south.

I have been monitoring the population on the Lake Erie Islands since 2012. In September, on the islands, there are "roosts" or clusters of butterflies in the trees at night, utilizing the same trees each year. The roosts are similar to the overwintering sites they create in Mexico. I have witnessed as many as a few hundred butterflies to several thousand roosting at one time. The butterflies rely on their geographic compass, weather conditions, the sun's angle, and food sources to

migrate. The Lake Erie Islands provide nearly all of these needs for them to successfully cross the lake when the weather conditions are not favorable or they need to rest.

This will be my twelfth year tagging monarch butterflies, tagging over 3,000 butterflies on the islands (North Bass, Middle Bass, South Bass, and Kelleys Island). I have had ten recoveries in Mexico, all from South Bass Island. Like many migratory animals, weather is one of the biggest factors that impact migration. I rely on the weather forecast to predict when the "peak migration" will occur on the islands.

My monitoring and tagging data have proved a few things: During the peak migration, is when I have had ALL the recoveries from Mexico. This leads me to believe that most butterflies that make it to Mexico are part of the "peak migratory butterflies." The data shows that the peak migration dates change (phenology). The earliest peak migration was September 10th, 2021,

and the latest was September 27th, 2012. The data also shows it is not how many butterflies you tag to have recoveries; it is when you tag. I have learned that just because there are many butterflies roosting or we are seeing hundreds flying across the lake does not mean it is peak migration.

Many people have asked me if the monarch butterfly population is lower this year than usual. The simple answer is yes. First, this year's overwintering numbers were the second lowest on record (0.9ha), and it was reasonable to expect low numbers of monarchs to return from Mexico in March. Second, high March temperatures allowed monarchs returning from Mexico to migrate too far north too soon. Third, this summer's mean temperatures have been over +4.5F and have hurt growth. population High temperatures, especially if combined with low soil moisture, result in a reduction of lifespan, egg laying, and larval survival, in effect, a reduction

in what is known as realized fecundity or the ability to produce abundant healthy growth or offspring.

Overall, the outlook is mixed. If the weather conditions in the Upper Midwest remain close to the longterm average through August, the migration could represent a remarkable recovery from a low overwintering population and a relatively small number of monarchs returning from Mexico. Further, if conditions are favorable through the migration, there is the possibility that the numbers this winter could represent the strongest recovery in the record. But, reaching that lofty goal will surely be out of reach if the drought conditions in Mexico persist into October.

We will continue to tag and monitor the monarch migration this fall, starting in early September on the Lake Erie Islands. We will keep everyone posted on our tagging locations and times. And we are hoping the population will rebound!



The Presidential Election – November 1888

November 3, 1888 – "Damage to the telegraph cable occurred somewhat regularly and we find that our Kelley's Island friends should have their cable repaired by Tuesday night, so as to be able to get elections returns." November 10, 1888 – "Official returns for the Presidential election for the island: Cleveland and Thurman-147; Harrison and Morton-141. [Gen. Benjamin Harrison and Hon. Levi P. Morton would be inaugurated President and Vice-President on March 4, 1889.] The Harrison and Morton pole on Kelley's Island is said to be a sight to behold. At least a dozen flags and ensigns are floating therefrom." "The Republicans had their final 'blow out' on last Wednesday evening. The Harrison and Morton Club had a grand torch light procession, about 90 being in line.

"Some of the houses on the line of march were beautifully illuminated. Those particularly noticeable, being: Henry Elfers, Fred Elfers, F. M. Kelley, G. P. Bristol, Herman Suhr, Addison Kelley, Mrs. H. Kaster [Koster] and the Himmelein House.

Mr. Addison Kelley borrowed a very fine rooster of Geo. P. Bristol and put him in the window. The lights were turned down awaiting the procession, when it came in sight around the corner of the street, the lights were turned up to their utmost capacity which so dazzled his roostership that he 'wilted' right down, so that but few saw him at all. Some of those philosophically inclined, attribute his actions to the fact of his being a Democrat.

After the procession disbanded, the members wended their way to Kelley's Hall to trip the light fantastic toe. Here were finally congregated some 250 'fair women and brave men' (and children) the like of which was never before seen on the Island. The patriotic Harrison and Morton ladies served the supper, and in just 11/2 hours from the time the first person sat down to the tables the last table was out of doors and the floor cleared for the dancers. 200 invitations were issued, every Republican voter received one, and also 15 or 20 of the Democrats who were known to enjoy a good thing when they see it. It is said that one or two of the latter tore up their cards when received. This certainly showed very poor taste, as they were issued with the very best of feeling, and intended as a compliment.

The Cleveland and Thurman pole was gathered to its fathers last week. The Harrison and Morton pole will be left until after inauguration day, and should the movement on foot for making this place a signal display station prove successful the pole will be left standing for the purpose of hoisting signals thereon. It is 85 feet out of ground and stands on the hill directly in front of the telegraph office [in the Store on the Corner-The Lodge], the location being all that could be desired."

Cook sausage and drain. Set aside.


In medium bowl, add cream cheese, onion, Parmesan, garlic powder, salt and pepper. Mix well.


